When I was in discussions with the trustees about taking up this post they were very clear that the Foundation has an important part to play in the fabric of Northern Ireland and has a history of leading the way on social justice issues. We were agreed that this was a new era for the Community Foundation and essential that we charted a new course that genuinely valued the past but was not afraid to look to the future. It has been an enjoyable time meeting the staff, the grantees and the funders and hearing about the amazing work we do. Working with our new Chief Executive Andrew and our wonderful trustees to collectively agree our way forward has been inspiring. In the past 12 months a number of important highlights within grant making, philanthropy and community leadership have let me know that we are on track and on the right path. The outcomes of our grant making funds, programmes and evidence of real impact from the work we have done in partnership with other funders are clear and positive signs. Our recent commissioning of Vital Signs quality of life research is also a significant point as it marks our focus on building robust data based on need, and the start of our work mapping philanthropy in Northern Ireland.

We know this cannot be done alone and we have been working with strategic partners to make sure our research will benefit a range of organisations.

Behind every great organisation there is a strong Board and I have had the pleasure of working with a range of great trustees who never fail to impress me with their passion and commitment to social justice and the Community Foundation. I want to particularly thank Tony for his contribution to the foundation as a trustee for the past nine years and also for his support in handing over the reigns as Chair. We have also said a fond farewell to Geraldine Donaghy, Bernadette Laverty and Carmel O' Connor and on behalf of the Foundation I thank them for their commitment, support and direction over the years. As we say goodbye to those that must leave us, the Board are currently working to recruit and induct new trustees into the Foundation, with a focus on the skills needed to deliver on our strategic objectives. It's exciting times ahead and also a good time to thank the staff and all who have supported the Foundation over the past 12 months.

Chief Executive Report

I am delighted to report on another exciting and successful year for the Community Foundation as we continued to bring donors and local communities together.

Thanks to the generous support of our donors and funders we were able to approve over £9 million in grants to 264 individuals, organisations and groups throughout Northern Ireland; supporting a wide range of causes and identified needs.

Working alongside many high profile funding organisations as well as individual donors and corporates has enabled us to work in areas where few other funders reach, supporting a range of causes and individuals marginalised in our local community.

The early part of 2016 saw heightened public awareness about the plight of refugees which we responded to on a local level with the launch of our £75,000 'New Beginning's fund'.

Individual and family funds like the Thomas Devlin Fund have provided a wide range of support to local communities. We were delighted to also support new family funds, namely the Ann McGeeney Trust Fund, set up by Seamus Murray in memory of his wife Ann, and the Mike Moloney Fund which aims to continue Mike's work in supporting arts activities with newly released prisoners.

We continued to work with a number of businesses including BT, Santander and Ulster Bank as well as providing administration for Community Benefit Funds across NI.

As the funding environment becomes ever more difficult and competitive, I am pleased to report that 50% of applications received were approved; a measure of our ability to reach need and a fact we are very proud of as we continued to act as a catalyst and lever for other funders.

2015/16 represented a period of re-thinking at the Foundation as we sought to remain responsive to the changing needs of communities and working in partnership with strategic funders as evidenced through our ongoing relationships with Building Change Trust, the International Fund for Ireland and the Big Lottery funded Space & Place programme.

Supporting Philanthropy Fortnight 2015 was a highlight in our on-going work promoting philanthropy across NI.

Our future work will be influenced by community need, donor consultation and our Vital Signs research; an extensive community engagement consultation which began to uncover the priority issues for people living in Northern Ireland.

Our aim is to encourage philanthropists by providing up-to-date information about community need and guide their giving for maximum impact.

Looking ahead, our plans are ambitious and over the next three years we will further invest in our local community, supporting 2,000 individuals, groups and organisations on the margins of society.

We will also empower communities by raising the game in the participation, involvement and problem solving that we do together across society.

We cannot however do this alone and we will continue to act as a key connection between people who care and causes that matter.

In so doing, it is our hope that we will contribute towards a peaceful, shared and socially just Northern Ireland.

GRANTEE STORY > Gortilea Social Farm



In 2015, Gortilea Social Farm near Claudy received a bursary of £3,000 from the Women's Fund NI to run a programme of activities for women with learning disabilities. DONOR STORY > Paula McFetridge - Mike Moloney Arts Bursary Fund

"The smallest intervention by somebody that believes in you will change your life," says Paula McFetridge. She credits Mike Moloney one of the original founders of Belfast Community Circus and the Prison Arts Foundation as being that crucial intervening force in the lives of many people, in particular those within Northern Ireland's prisons.

A desire to continue this element of Mike's work and to honour Mike after his sudden death, is why Paula along with a number of Mike's friends set up the Mike Moloney Arts Bursary Fund in partnership with the Community Foundation for Northern Ireland. "The bursaries are about forging links between the motivation and hope individuals are given via the Prison Arts Foundation when they are inside prison and much-needed creative support on their release. It's to give people a possibility of change," says Paula.


The Fund recently made its first grants including support for the Lyric Theatre's production of 'Blackout' which toured to schools across Northern Ireland, in partnership with Hydebank Wood College and the PSNI.



GRANTEE STORY > Jonathan Woods

An Acorn Fund Inspire Bursary gave young artist Jonathan Woods the chance to follow his dreams. Jonathan was able to spend eight weeks working with artist and mentor Mhairi Sutherland. Supported by the Paul Hamlyn Foundation, The Acorn Fund supports young people with disabilities helping them pursue training in their chosen arts. The culmination of Jonathan's mentoring led to him holding his first ever exhibition in the Void Gallery in Derry.

GRANTEE STORY > **New Beginnings Fund for Refugees and Asylum Seekers**

Launched in response to an urgent need presented by refugees arriving in Northern Ireland, CFNI's refugee fund provided support for communities working with new arrivals and those in the process of trying to establish a new life in local communities here. Deirdre Walsh from Whiterock Créche Association which received funding of almost £10,000 said: "The Community Foundation has enabled us to offer a little respite to refugee and asylum seeker families who have made West Belfast their home. Many of these families have come from horrific situations and are in some cases living in very dire situations here with limited income.



GRANTEE STORY > Aquapsychotherapy - Building confidence and self esteem through Scuba Diving




Belfast charity Acquapsychotherapy was formed by Mariano Bisso a paramedic and scuba diving instructor and Christine Cushnahan a psychology graduate, to support people with physical disabilities. Mariano teaches people how to scuba dive in the safety of a swimming pool whilst Christina carefully observes each person and works with them to assist with any wider psychological issues they might have as a result of disabilities.


According to Mariano, "scuba diving is perfect for people who are limited in their physical capabilities or what they think they are capable of. We often see people's confidence build and from that a lot of other qualities come; scuba diving gives people a sense of limitless possibilities which they wouldn't otherwise have." A grant from the BT and CWU Telecommunity Fund has supported them to continue their work.


