


Quality Accreditation and Governance

Community need in Northern Ireland

There is much to celebrate about life in Northern Ireland and as a Community Foundation we fund and support those who are making a difference where there are challenges; and we hear from across Northern Ireland the issues that people are facing within their communities.

We live in a community where there is significant poverty and inequality – a boy born in the most deprived areas of Northern Ireland could expect on average to live 7 years less than one born in the least deprived, there are 100,000 children living in poverty and more than half of our households spend 10% of their income keeping warm.

At the Foundation we use our unrestricted endowment to **get money to people who can't fundraise for themselves**. 

- **We are impartial and independent** – as independent advisors we do not favour any one particular cause or issue.
- **More than double your clients' donations** – through our matched funding.
- **Giving locally** – your clients can support the local community in which they live and work.
- **Quick and efficient** – we can set up a named fund within 24 hours compared with waiting several months or longer to register as a charitable trust.
- **Flexibility** – no two donors are alike and our donor services offer options and flexibility to suit your clients' needs. From starting a bespoke charitable fund, to collective giving with others; from leaving a legacy to donating now, your clients benefit from our funding expertise, matched funding, community knowledge and giving advice. 
BENEFIT FROM TAX EFFICIENT GIVING AND MATCHED FUNDING

- **We help clients give tax-effectively** – we are an ideal vehicle for all methods of tax-effective giving, including gift aid, relief from income tax, capital gains tax, inheritance tax and corporation tax.
- **We are permanent** – our endowment of £15m ensures we are here to stay, and the original intentions of your client are carried out without having to approach the Charity Commission for a variance of the original deeds of a trust or intentions in a will.
- **We are transparent** – we ask for a contribution towards our administration costs for managing a fund which varies depending on the size and type of fund, and we agree this, up front, with donors. We operate with a very low overall administrative overhead, which means that more money can go out in grants to the community.
- **We carry the financial and legal responsibility** – the onus on charitable trustees to invest and monitor funds, to ensure regulations are followed in grantmaking, to meet the stringent needs of accounting requirements and to report to the Charity Commission is increasing. When a fund is set up with the Community Foundation these responsibilities lie with our trustees.

- **Above all, we can offer you a personal and flexible philanthropy advice service, that will find a solution to meet and exceed your clients’ needs and expectations.**
