Establishing a Named Corporate Fund

You can choose to restrict your gifts to a geographical area, for example near your company offices, or to charitable activities, such as developing the skills of young people. The Community Foundation will promote and seek applications that meet your required criteria.

With flexibility at its core, this fund option allows for adaptable investment timelines, shared decision making and on-going tailored support.

Support an established fund such as The Inspiring Growth Fund.

Its mission is to empower local charities by building capacity to adapt, thrive and deliver a lasting positive impact on the individuals and communities they serve.
